TERMS AND CONDITIONS

Art. 1 – PROMOTERS – The Campania Region - Department of Ecology and Environmental Protection – Ecology Sector and the “*La Primula*” CEA (Environmental Education Centre) of Pisciotta, belonging to the Campania regional network INFEA, promote the workshop “*Crudelia and I A fantastic journey into the abyss*”.

Art. 2 - APPLICANTS – The workshop is open to all citizens of the world with no age restriction.

Art. 3 – REGISTRATION FEE - The contest is free.

Art. 4 - WORKS – The works, dealing with "biodiversity", can be realized through different forms of expression. They will be produced on paper and /or electronic form, according to the following guidelines:

- Writings (narrative, exposition and poetry), drawings and paintings (made with varied techniques and on A3 or A4 sized paper), collages, cartoons, photos and other graphic art on paper and electronic records. The works on paper that, for lack of suitable tools, cannot be transferred to electronic form, should be photographed or scanned and sent via e-mail.
- Videos (film, drama, video-story and so on) in electronic form.
- Sculptures - maximum size of 60 cm for the base - must be equipped with adequate photographic documentation

Art. 5 - HOW TO APPLY – Applicants may submit only one work, realized individually or in groups, using only the techniques and tools provided by the previous art.4.

Art. 6 – ADMISSIBILITY – Every work will be published on the website www.primulapalinuri.it and displayed in the travelling exhibition, after being judged relevant to the workshop theme by a commission appointed by the “*la primula*” CEA. The Commission, observing objective and transparent criteria, will evaluate all the projects and indicate the three best works. Its judgment will be final and unappealable.

Art. 7 – RECOGNITION OF QUALITY - Each of the authors of the three best works will be invited to join, as a guest, (an event organized by the “*la primula*” CEA during 2012. “*La primula*” CEA will provide free accommodation for the authors during the event.

Art. 8 – COPYRIGHTS – The authors, by taking part in the workshop, surrender their right of publication and exposure to the promoters of the same without any claims as copyright. The rights and works remain the property of individual authors. They will be able to recover their works at their own expense and at the end of the exhibition, which will have a maximum duration of twelve months.

Art. 9 – ADVERTISING – The workshop will be appropriately advertised in the press and through other media.

Art. 10 – FURTHER CONDITIONS – Taking part in the workshop implies the full acceptance of these terms and conditions without reservation. The lack of one of the above mentioned conditions, leads to automatic exclusion from the exhibition.
